## HOW TO OBTAIN AN IRS TRANSCRIPT OF YOUR 2022 TAX RETURN

Transcripts are provided by the IRS at no charge, and mailed to your home.

#### **OPTION 1: REQUEST YOUR TRANSCRIPT BY PHONE (IRS will mail in 5 to 10 days).**

**Call 1-800-908-9946.** You will get a recorded message. When you hear the messages listed below, press the number next to it or enter the information requested. *Keep this script in front of you as you place your call.*

## **DEADLINE TO FILE APPLICATION: OCTOBER 2, 2023.**

You must file for the tax credit annually to continue receiving the credit.
